This agreement is between John Harper Photography and (the client)

Date of wedding.....

1. This agreement contains the entire understanding between John Harper Photography and the Client. It supersedes all prior and simultaneous agreements between the parties. Only those changes or modifications specifically placed in writing, attached, dated and signed by the Clients and John Harper Photography at the time of acceptance of this contract shall be recognised as amendments to this contract.

2. Upon receipt of deposit, John Harper Photography will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation deposit of 25% of the coverage is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of God, fire, strike and/or extreme weather. The Reservation Deposit is to be paid at time of signing the contract. The Reservation Deposit is applied towards the contracted wedding photography package.

3. In the event that the Client cancels the contracted services for wedding photography outlined in this contract before the wedding ceremony takes place, the deposit will be forfeit. John Harper Photography agrees to refund all additional paid money (less expenditures for which receipts will be provided), to the client.

4. The Client understands and agrees that the entire amount owed for the wedding photography package is due two weeks before the date of the wedding.

5. In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. John Harper Photography will make every effort to secure a replacement photographer of the same professional standing and ability able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received.

6. John Harper Photography takes the utmost care with respect to exposure, transportation and processing of photographs. However, in the unlikely event of the Client's photographs being lost, stolen or destroyed for reasons within or beyond John Harper Photography's control, the latter's liability is limited to the return of all payments received for the event package, together with the reasonable costs of re- staging photographs of the couple and their families at a later date.

7. The Photographer will document the events in a candid manner and take formal portraits as necessary. The client should provide a full list on the details form of formal photographs required including names and relationship to the client.

8. Prior to or during the event, the Client may inform the photographer of subjects which they would like photographed, but the final content of the images is at the discretion of the Photographer.

9. Although every possible care will be taken to produce photographs of all important and special events during the wedding, John Harper Photography cannot place an unconditional guarantee on the above.

10. The client will receive an edited selection of high-resolution JPEG digital images. The entire copyright in the photographs is retained by the photographer at all times throughout the world. The client must seek permission for use beyond reproduction and printing for friends, guests and family.

11. The Clients hereby allow the photographer to display any images covered by this contract and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles, and other such media, providing that the images are used lawfully and without damage to the clients.

12. The photographer is limited by the guidelines of the ceremony official or the reception site management. The Client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is The Client's responsibility; John Harper Photography will offer technical recommendations only.

13. John Harper Photography will be the only professional photographer on the day of the wedding. John Harper Photography reserves the right to ask other people to refrain from taking photographs at key times, if it is considered that this may compromise the quality of the photographs.

14. If any provision of this agreement is held to be invalid or unenforceable under the law, the validity of this agreement as a whole shall not be affected, and the other provisions of the agreement shall remain in full force and effect.
